### Infrastructure Newsletter

#### Overview

It has been an interesting start to 2023 given the macroeconomic factors, especially in the latter half of the quarter. Infrastructure as an asset class has remained relatively unscathed from the macro news that has permeated traditional asset classes. Some familiar themes remain from last year, most notably the continued interest in energy transition and green investments as well as the continued growth of the private wealth IR function. This quarterly newsletter highlights some of the key senior hires within the UK infrastructure space as well as highlighting some key trends and insights in the market.

#### Fund Raising



For the last few years, private infrastructure fundraising has risen year after year. It reached a new high in 2021 of \$156bn. This was then bettered in 2022 rising to \$162bn. The subsequent effect of this has been the average size of funds is now just under \$2bn. GPs now have more capital to deploy than ever before and managers have been expanding their investment teams considering this. This quarter both Equity and Debt funds have been hiring across all levels of seniority which is unsurprising given the significant war chests managers now have access to.

#### Sustainable Investing




Energy transition is now a key market for private investors, and we have seen several notable fundraises in the first quarter of 2023. Energy Infrastructure Partners have closed their first energy transition fund. Just Climate, Brookfield, KKR, and Stonepeak are other examples. Furthermore, Blackstone is on course to raise their fourth energy transition fund which will close in the summer. In line with this growth, Valentine Thomas has witnessed the growth of the dedicated sustainable investment function, Stonepeak being the latest to hire a senior investment professional.


#### Looking Ahead



Looking further ahead, Valentine Thomas & Partners can expect infrastructure to continue to garner headlines. Nuveens Equilibrium Global Institutional Investor Survey found 59% of EMEA investors are looking to increase their alternatives allocation with the majority saying they would choose infrastructure. This is due to the asset classes' ability to play multiple roles including inflation protection, increasing yield and mitigating climate risk. Given this, we can expect to see growth hires throughout the year with many managers building their investment function to deploy growing funds and the IR function continuing to grow given the continued interest in the asset class.
